MOTOR CITY BOWLERS GUILD FALL QUAD MIXER TOURNAMENT RULES

- 1. This tournament is open to all USBC certified bowlers.
- 2. This tournament will be bowled in accordance with rules adopted by USBC.
- 3. AVERAGE REQUIREMENTS: SUMMER AVERAGES WILL NOT BE ALLOWED.
 - a. Bowlers must use the highest USBC Certified league average of not less than 21 games of prior season (2018-2019).
 - b. Bowlers with no average must bowl with a 220 average.
 - c. If as of 10-26-19 a bowler has a current average for 21 games or more that is 10 pins higher than the prior season's average, then the higher average must be used.(USBC Rule 319 A-2)
 d. USBC Rule #319A-3 will apply to all participants of this tournament.
- 4. It shall be each bowler's responsibility to verify the accuracy of his or her average. In accordance with USBC Rule 319A-3, whether originally submitted by the bowler, the team, or others. Failure to use the correct average shall disqualify the score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. You will have until the end of your 1st game to verify the correct average. If after that said time if the average is found to be incorrect the score shall be disqualified. Prize winning shall be based on the submitted average if it is higher than the correct average. Tournament Director has the right to re-rate any bowler.
- 5. Check in begins 60 minutes prior to squad time.
- 6. Handicap will be 80% of 220 on an individual basis for singles and 80% combined for mixed doubles. Touring Pros or current PBA card holders are not eligible.
- 7. Prize fee will be returned 100% in each event which it is collected. There will be at least 1/8 ratio for this Quad Tournament.
- 8. In the event of mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available lanes in the establishment at the discretion of the Tournament Director.
- 9. No entry application will be accepted unless accompanied by entry fees. No entry fees will be returned once scheduled.
- 10. Premature termination of the tournament brought out by war, national emergency or emergency causes relating thereto or there from; fires, strikes, lockouts, weather, labor difficulties or other reasons beyond the control of the Bowling Center shall cause the foregoing prize schedule to be prorated in accordance with the number of entrants who have bowled.
- **11. All decisions made by the Tournament Director are final.**
- 12. There must be one lady per team to bowl in the tournament.
- 13. USBC RULES WILL APPLY TO ALL OTHER RULES NOT COVERED ABOVE.
- 14. You do not have to be sponsored by an M.C.B.G. member in order to bowl.
