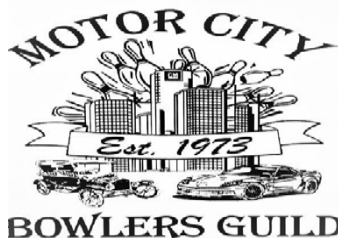

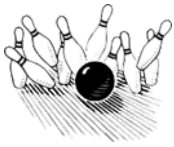

## MOTOR CITY BOWLERS GUILD SPRING FLING MIXED DOUBLES HANDICAP TOURNAMENT RULES



1. This tournament is open to all USBC certified bowlers.
2. This tournament will be bowled in accordance with rules adopted by USBC.
3. AVERAGE REQUIREMENTS: SUMMER AVERAGES WILL NOT BE ALLOWED.
  - a. Bowlers must use the highest USBC Certified league average of at least 21 games of the prior season (2024-2025).
  - b. If a bowler has a current average of 21 games or more in a winter 2025-2026 league, they must bring a league sheet (**dated April 4-10, 2026**), to the tournament to verify their average on the day of the tournament.
  - c. Bowlers with no average or an average that cannot be verified must bowl with a 220 average.
  - c. If, as of 04-01-26, a bowler has a current average for 21 games or more that is 10 pins higher than the prior season's average, then the higher average must be used. (USBC Rule 319 A-2)
  - d. USBC Rule #319A-3 will apply to all participants of this tournament.
4. Each bowler shall be responsible for verifying the accuracy of his or her average. In accordance with USBC Rule 319A-3, whether originally submitted by the bowler, the team, or others. Failure to use the correct average shall disqualify the score if the submitted average is lower than the correct average, resulting in a lower classification or more handicap. You will have until the end of your 1st game to verify the correct average. If the average is found to be incorrect after that time, the score shall be disqualified. Prize winning shall be based on the submitted average if it is higher than the correct average. The Tournament Director has the right to re-rate any bowler.
5. Check-in begins 90 minutes prior to squad time.
6. **Replacement bowlers will not be accepted 30 minutes before the start of the tournament.**
7. Handicap will be 80% of 220 on an individual basis for singles and 80% combined for mixed doubles.
8. Teams over 440 may bowl scratch only.
9. The maximum score per game with handicap is 300. The pre-game and total handicap will be adjusted accordingly to determine the total handicap score. Individual total scores will not exceed 900 with the handicap.
10. Touring Pros are ineligible to participate.
11. The prize fee will be returned 100% in each event in which it is collected. There will be at least a 1/8 ratio in Mixed Doubles.
12. In the event of mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available lanes in the establishment at the discretion of the Tournament Director.
13. No entry application will be accepted unless accompanied by entry fees. **No deposits or entry fees** will be returned once scheduled.
14. Premature termination of the tournament brought out by war, national emergency, or emergency causes relating thereto or therefrom; fires, strikes, lockouts, weather, labor difficulties, or other reasons beyond the control of the Bowling Center shall cause the foregoing prize schedule to be prorated in accordance with the number of entrants who have bowled.
15. The Tournament Director can accept, reject, or disqualify any entry.
16. All decisions made by the Tournament Director are final.
17. **USBC RULES WILL APPLY TO ALL OTHER RULES NOT COVERED ABOVE.**
